



Highlights of the Communiqué

• Core leader

The meeting officially declared "the CPC Central Committee with Comrade Xi Jinping as the core."

02

Authority of CPC Central Committee should be firmly upheld

Ensuring the authority of the CPC Central Committee and the proper execution of orders of the Party are concerned with the destiny of the Party and the state.

They are also concerned with the fundamental interests of the people of all ethnic groups in China, and they are important purposes of strengthening and regulating intra-Party political life.

A leading core is vital to a country and a political party. The entire Party should consciously maintain a high degree of consistency with the CPC Central Committee in thoughts, politics and actions.

Strict requirements on senior officials

Party organizations at all levels and all Party members, especially senior cadres, should conform to the CPC Central Committee and CPC theory, path, principle and policy, as well as decisions made by the CPC Central Committee.

04

Unrestricted power, unsupervised Party member not allowed in CPC

Supervision is the fundamental guarantee for exercising power properly, as well as a crucial measure for strengthening and regulating political life within the Party.

Party organizations and leading officials must not hide violations of Party discipline and laws, or problems reported by Party members, and must deal with such issues in a timely manner.

Leading officials involved in issues reported should not participate in, intervene or meddle with investigations.

• No prohibited zone in intra-Party supervision

Intra-Party supervision should be carried out in accordance with regulations and by observing the principles of democratic centralism, top-down organizational supervision, democratic supervision from the bottom to the top, and peer review or critique.

The mission of intra-Party supervision is to ensure the Party Constitution, its regulations and code of conduct are enforced effectively; to maintain Party unity and solidarity; and, primarily, to resolve Party leadership enervation and slackness in Party building and governance as well as discipline slackening.

Democratic centralism is the Party's fundamental organization principle and a significant system guarantee for intra-Party political life.


12 Promotion of Officials

Xi Jinping's Explanation of the New **Political Norms and Regulation**

The sixth plenary session of the 18th CPC Central Committee deliberated and adopted the "Norms of Political Life Within the Party Under the New Situation" and the "Regulation on Supervision Within the Communist Party of China." Xi Jinping, general secretary of the CPC Central Committee, provided a detailed explanation of these two important documents during the plenary session.



Several Considerations Involved in the Drafting of the Documents





In short, facing new situations and tasks, it is necessary to establish new norms of political life within the Party, and the regulations on supervision within the Party must be revised. As timing and conditions are mature, demands are urgent.

The Drafting Process



1,955 suggestions on possible amendments were received. After elimination of repetitions, the figure was reduced to 1,582 . 354 suggestions were opinions on matters of principle, and **1,228** covered specific points.



The Standing Committee of the Political Bureau of the CPC Central Committee held 🖁 meetings, and the Political Bureau held 🙎 meetings to review the drafts.



The Principles of Drafting

- Carrying forward the fine traditions and valuable experience of the Party. Highlighting the theme of comprehensively strengthening Party discipline.
 - ✓ Adhere to the Party Constitution as the fundamental basis.
 - Focus on the problems and weak links existing in the political life within the Party and in the supervision of this aspect.
 - Adhere to coordination in an overall manner, strengthening toplevel design and systematic planning, dealing with the relationship between the old and new Norms and Regulation, and other rules and regulations within the Party, to ensure the new Norms and Regulation reinforce the existing rules and also develop with the times.


Two Issues Highlighted in the Explanation

First is the relationship between the new Norms and those issued in 1980.

In the process of drafting, the main principles and provisions of the Norms established in 1980 have been emphasized. New and old Norms are interrelated and relevant; hence, both must be followed in political life within the Party at present and in the future. The other issue relates to high-ranking



officials.






Emphasize on solving such problems as extravagance and waste, splurge, complacence, dissipation, corruption and decadence



How Supervision Within the Party Is Carried Out

The Regulation on Supervision Within the Communist Party of China, approved at the sixth plenary session of the 18th CPC Central Committee was made public on Nov. 2, 2016. It consists of eight chapters and 47 articles, delineating duties of the four major supervision bodies and the relative supervision system.





To enhance and regulate the political life within the Party under the new situation, all CPC members must adhere to the Party Constitution as the fundamental basis and adhere to the Party's political line, ideological line, organizational line and mass line.



The mission of supervision within the Party



The mission of supervision within the Party is to ensure the Party Constitution, its regulations and codes of conduct are enforced effectively; to maintain Party unity and solidarity; and, primarily, to resolve Party leadership enervation and slackness in Party building and governance as well as discipline slackening. Supervision will ensure that Party organizations perform their due duties, all members play vanguard and exemplary roles, and leading officials are loyal, clean and accountable.



Measures Taken by the Central Leading Group for Comprehensively Deepening Reforms to Tighten Party Discipline

Jan. 22 2014

1st Meeting

The meeting deliberated on and adopted the decision of the Central Leading Group for Comprehensively Deepening Reform to establish sub-groups in charge of reforms in six areas, including the economy and ecological civilization, democracy and law, cultural system, social system, system of Party building, and discipline inspection system.

Dec. 2 2014

7th Meeting

The meeting deliberated on and adopted the documents regarding strengthening the building of delegated agencies of the Central Commission for Discipline Inspection of the CPC.

Feb. 27 2015

10th Meeting

The meeting deliberated on and adopted the Provisions on the Recording, Notification and Accountability of Intervening into Judicial Activities and/or Handling of Specific Cases by Officials, and a pilot project to supervise the business activities of relatives of officials in Shanghai.

Jul. 1 2015

14th Meeting

The meeting deliberated on and adopted the documents including the Pilot Plan on Implementing Audit of Outgoing Leading Officials' Natural Resources/Assets Accountability and the Measures for Bringing Party and Government Officials to Account for Damage to the Ecological Environment (for Trial Implementation).

Apr. 18 2016

23rd Meeting

The meeting deliberated on and passed the documents of Beijing, Guangdong, Chongqing and the Xinjiang Uygur Autonomous Region on regulating business operations by family members of officials (for trial implementation).

Aug.18 2014

4th Meeting

Xi Jinping, head of the Group, said that persons in charge of state-owned enterprises (SOEs) must make sure that their salary level is proper, their salary structure is reasonable and their salary management is strict and efficiently supervised. He also urged SOEs to strictly follow the Party's "eight-point" guideline against bureaucracy and extravagance.

Jan.30 2015

9th Meeting

The meeting deliberated on and adopted the documents which stipulated the procedures for nomination and assessment of secretaries and deputy secretaries of discipline inspection commissions at provincial-level, heads and deputy heads of stationed inspection teams sent by the Central Commission for Discipline Inspection of the CPC, as well as secretaries and deputy secretaries of inspection commissions at SOEs.

Jun. 5 2015

13th Meeting

The meeting deliberated on and adopted the Guidelines on Deepening Reform of State-owned Enterprises and Stressing the Party's Key Role in Supervising the Enterprises' Management and Operation, and the Guidelines on Strengthening the Supervision and Administration of State-owned Assets and Preventing the Loss of State-owned Assets.

Jan. 11 2016

20th Meeting

The meeting deliberated on and adopted the documents including the Regulations on Protecting and Awarding Whistleblowers in Duty-related Crimes.

Plenary Sessions of the

18th CPC Central Committee



The Central Committee of the Communist Party of China (CPC), elected by the CPC National Congress, convenes at least one plenary session every year.



First Plenary Session

It was held in Beijing on Nov. 15, 2012.

The CPC Central Committee elected its political Bureau, the Standing Committee of the Political Bureau and the General Secretary of the CPC Central Committee. It also endorsed the members of its Secretariat nominated by the Standing Committee of the Political Bureau, decided on the members of the Military Commission of the CPC Central Committee, and approved the candidates for secretary, deputy secretaries and standing committee members of the CPC Central Commission for Discipline Inspection.



Second Plenary Session

It was held in Beijing from Feb. 26 to 28, 2013.

A list of candidates for state leadership positions and a list of candidates to fill leadership roles for the 12th National Committee of the Chinese People's Political Consultative Conference (CPPCC) were approved. The two lists were later proposed respectively to the first annual session of the 12th National People's Congress (NPC) and the first annual session of the 12th CPPCC National Committee. The Plan on Restructuring and Transforming Functions of Government Departments Under the State Council was also approved.



Third Plenary Session

It was held in Beijing from Nov. 9 to 12, 2013.

The plenum approved the Decision of the CPC Central Committee on Some Major Issues Concerning Comprehensively Deepening the Reform.



Fourth Plenary Session

It was held in Beijing from Oct. 20 to 23, 2014.

The plenum approved the Decision of the CPC Central Committee on Some Major Issues Concerning Comprehensively Advancing Rule of Law. The Decision states that the general target is to form a system serving the socialist rule of law with Chinese characteristics and build a country under the socialist rule of law.



Fifth Plenary Session

It was held in Beijing from Oct. 26 to 29, 2015.

The plenum adopted proposals for the country's economic and social development in the 13th Five-Year Plan (2016-2020).



Sixth Plenary Session

It was held in Beijing from Oct. 24 to 27, 2016.

The session called on all Party members to "closely unite around the CPC Central Committee with Comrade Xi Jinping as the core." Two documents were deliberated and adopted, namely the Norms of Political Life Within the Party Under the New Situation and the Regulation on Supervision Within the Communist Party of China, according to a communiqué released right after the session.

The session also passed a resolution on convening the 19th CPC National Congress in the latter half of 2017.
